

2020 EMS System Education & Training Guidance

Muskegon County Medical Control Authority Education Committee

Purpose

This document establishes and promulgates policies and procedures for consistent and structured education and training requirements within the Muskegon County Medical Control Authority (MCA) for the 2020 calendar year.

Background

The Medical Control Authority is responsible for the design and oversight of the EMS system, to include the establishment of written protocols which provide for the provision of EMS care. Life Support Agencies are responsible for ensuring licensed personnel are trained on all equipment, policies, procedures and protocols, and are accountable to the Medical Control Authority in the provision of emergency medical services. Both the Medical Control Authority and Life Support Agency are required by statute to maintain a quality improvement program.

As a part of the Quality Improvement process, the MCA evaluates system-wide areas of concern and opportunities for improvement. While the MCA makes efforts to address each of these improvement opportunities, it is our intent to select a few “Principle Subject Areas” each year that warrant the highest level of attention, and to place the bulk of resources toward addressing these opportunities. Other “Additional Subject Areas” are included in this document but will require fewer resources to accomplish. In addition, two optional subject areas have been included for agencies who wish to further their effectiveness and raise the bar in areas of additional training and leadership.

Coordinating Instructions

Life Support Agencies should use this document to plan and build their education calendars. All training and education shall be conducted in accordance with approved Medical Control Authority (MCA) standards (i.e., must be conducted by an approved instructor, through an approved education program, using approved lesson plans and education templates). Before teaching a topic, instructors should attend applicable train-the-trainer sessions with the Medical Control Authority.

All courses taught under these guidelines will be posted to the Medical Control Authority website education calendar once approved by the Medical Control Authority. If providers are unable to attend a required training within their own respective agency/department, they are encouraged to visit the website to locate additional training opportunities at www.wmrmcc.org/Calendar.

Instructors

All education & training should be taught by qualified instructors who are part of the MCA's CE Consortium, or approved by the Education Committee on a case-by-case basis. Agencies which do not have qualified instructors should review the current list of approved instructors at www.wrmcc.org/MCA/Muskegon/CE-SPONSORSHIP/Approved-Instructors and make arrangements with existing instructors, or submit to the CE Sponsor to have an instructor added. When selecting an instructor, agencies should ensure the instructor is appropriate for the topic being taught (e.g., some topics require specialized knowledge and/or credentials).

Before teaching a topic, instructors should attend applicable train-the-trainer sessions with the Medical Control Authority.

Note: It takes at least 30 days to have an instructor added to the CE Sponsor Consortium.

Instructional Materials

It is the goal of the MCA to foster consistent training & education standards. All education & training conducted as a result of this document should be done using existing instructional materials created and/or approved by the Education Committee, including lesson plans, objectives, outlines, presentations, quizzes, tests, etc. Instructors can find these resources at www.wrmcc.org/MCA/Muskegon/EDUCATION/IN-SERVICE-TRAINING

Continuing Education Credits

The Education Committee is committed to ensuring CE credits are available for all education & training, to the extent possible. Credits can be obtained through the CE Sponsor Consortium by following current policies for conducting a course, which can be found at www.wrmcc.org/MCA/Muskegon/EDUCATION/CE-SPONSORSHIP and clicking on '**Course Policy**' under the "**Policies & Procedures**" section. Unfortunately, for topics that are under 30 minutes credits will not be available.

Compliance

It is the responsibility of both the individual provider and the agency to ensure the provider is up-to-date with current credentialing requirements, which includes attendance of any mandatory system in-service or skills stations (see: **Medical Control Privileges Protocol and Addendum**). Course completion paperwork can typically be submitted by the instructor to the CE Sponsor Consortium, including attendance rosters, which will serve as the primary measurement of compliance. (see: Compliance under each topic area for more specific instructions).

The Medical Control Authority will conduct audits of compliance with these education guidelines. Failure to comply will result in disciplinary action of either the provider and/or agency as outlined in applicable protocol and policies.

This training guidance was formulated based on consensus of both the Education and Advisory committees and was driven by various quality improvement initiatives of the Medical Control Authority.

Enhanced Paramedic



ALS ONLY

All Advanced Life Support licensed agencies who regularly conduct interfacility transfers shall facilitate for each licensed Paramedic to receive MCA approved education & training at the “Enhanced Paramedic” level, as outlined in current protocol (July 2018). These trainings will include both online eLearning and hands-on practical skills components.

- Antibiotics
- Antivirals
- Blood & blood products
- Colloids, crystalloids, lipids
- Heparin
- Nexium (esomeprazole)
& Protonix (pantoprazole)
- Nitroglycerine
- Mag. sulfate/Calcium gluconate
- Pepcid (famotidine) & Zantac (ranitidine)
- Potassium (up to 20 mEq)
- Sodium bicarbonate
- TPN (Total Parenteral Nutrition)
- Tranexamic Acid (TXA)

Just Culture is a leadership program by the Center for Patient Safety that aims to reshape our understanding of accountability, the role of the system, and the role of human behavior. Just Culture helps leadership to establish a culture that encourages open reporting of adverse events and risky situations, yet hold people and organizations accountable in a just manner.

BDLS/ADLS

Basic and Advanced Disaster Life Support are courses designed by the National Disaster Life Support Foundation. NDLSF is dedicated to the establishment and propagation of standardized, all-hazards, multi-disciplinary, and competency-based training programs.

BDLS is an 8 hour competency-based, awareness-level course that introduces concepts and principles to prepare health professional for the management of injuries and illnesses caused by disasters and public health emergencies. BDLS is a pre-requisite to ADLS.

ADLS is an intense 2-day, 15-hour course that allows participants to demonstrate competencies in mass casualty management.

It is the goal of the MCA to see every leader in the system attend an ADLS course within the next three years. The next ADLS course will be announced soon and posted to the MCA education calendar at www.wmrmcc.org/Calendar. The pre-requisite BDLS courses are routinely scheduled throughout the region. Dates and locations can be found at www.wmrmcc.org/Calendar, or by contacting Luke Aurner, Region 6 Healthcare Coalition Coordinator. Both courses are free of charge and are pre-approved by the Bureau of EMS, Trauma & Preparedness for several CE credits (see MDHHS Pre-Approved CE Course at www.wmrmcc.org/MCA/Muskegon/EDUCATION).

ICS 300: Intermediate ICS for Expanding Incidents

This course provides training on and resources for personnel who require advanced application of the incident command system, and expands upon information covered in the ICS-100 & 200 courses.

Courses will be scheduled locally in Muskegon County and are available throughout Michigan.

ICS 400: Advanced ICS Command and General Staff Complex Incidents

This course provides training on and resources for personnel who require advanced application of the incident command system, and expands on information covered in the ICS-100, 200 and 300 courses.

EMS Quality Improvement Program (EQIP)

This course is designed to provide the EMS leader with the baseline knowledge needed to administer a quality improvement program within their respective agency. The goal of the system is to provide safe, effective, efficient, patient-centered care in a timely fashion. This is accomplished, in part, by providing leadership to the EMS community to establish best practices and collaboration amongst stakeholders to provide the highest quality care to patients through a rigorous EMS Quality Improvement Program.

Patient Documentation: ALS & FD

Patient documentation is a critical aspect of EMS patient care. Quality patient care reports support the clinical, operational, legal, and reimbursement aspects of your agency. EMS agencies and providers should continue to work on improving their patient care reporting. Some of the more common concerns the Medical Control Authority continues to see include the following:

- Poor spelling, bad grammar & use of improper acronyms and abbreviation
- Narrative does not “paint a picture” of patient’s true condition
- Inconsistencies
- Incomplete documentation

Throughout 2020, the Medical Control Authority will continue to work with its agencies and providers to improve our patient care reporting. Education is currently available on our website, and more will be added throughout the year.

HazMat Decon: ALS & FD

The intent of this course is to provide refresher information on recognition and mitigation of a hazardous materials incident, including patient decontamination, with a focus on keeping providers and patients safe from exposure and contamination by toxic substances. While the prevalence of such responses is moderately low, there have been a number of documented incidents where contaminated patients have not received proper decontamination and were transported to local emergency departments, contaminating ambulances and emergency departments in the process, and putting providers at risk.
